#### FROM THE PRESIDENT - JULY 1986

For some time there has been talk among members discussing the Club's goals, purpose, and direction. Some have gone so far as to say that the Club really doesn't know where it is going or what it wants to do. A few are very concerned about this. This month I would like to offer a facet of our Club's history to anyone who doesn't know it, in hope that it will help you understand why we are the way we are. I attended the very first meeting in the Summer of 1976 and paid my dues as a founding member. I have followed this club through it's ups and downs, and have presided over it once before, in early 1978.

In 1976 when the Contest Club was formed, it was a bunch of gung-ho guys who wanted to murder all comers in Club Aggregate Competition. The Club promptly fell apart a little less than two years later because the members ultimately didn't have a strong enough commitment to that goal. In 1980, when Tree, N6TR, picked up the rubble, we reorganized with a totally different purpose - to eat pizza and drink beer (ROOT beer in some cases) and have a good time talking about contest operating.

All comments to the contrary, This is our Club's primary purpose to this day. The Club that was re-formed in 1980 bears little resemblance to the club that was formed in 1976. The SCCC gives hams interested in contesting an opportunity to rub elbows with their primary competitors, have lunch together, tell stories to each other, and exchange ideas.

There was one other thing we decided we wanted to do in 1980, come to think of it, and that was to put together the most killer DXpedition to Mexico that had ever happened. Well, we did it. It took three years of planning, but in October 1983, twelve die-hard, laugh-at-danger operators from the ranks of the Club spent about \$68.00 each and put XE2SI on the air, Multi-Multi, for 48 hours in the CQWW SSB Contest. Probably the highest points-to-dollars-spent ratio in the history of Contest DXpeditions.

Considering that these are the only goals we have ever set for ourselves, I'd say that our Club is pretty good at setting goals it can meet, and following through on them. Since the attendance at our regular no-program lunch meetings and barbeques and open houses keeps going up, I'd say we're in pretty good shape. There's certainly lots of story telling and statistic swapping going on at the meetings, and a meeting seldom goes by when the ranks of the world class operators are not represented, usually in force. Many times we have had visitors in attendance from other places in the world who share our common interest in operating contests.

The new Club in 1980 expressly forbade paperwork or official procedure of any kind, except for a small bulletin that went out to members announcing the next meeting. That is how we kept our dues to \$2.00. That brings us to today. Today we have essentially the same club, except that it has grown in size from the ten of us in 1980 to a roster of about fifty now.

It is easy for me to understand that some of our newer members aren't aware of some of the things I have described above, and because of some of the comments I've been hearing over the last couple of years, I felt I should clarify it.

I recognize some problems in our current situation. With fifty members, I can no longer hope to maintain the simple structure our club once prided itself for having. You can't do much with \$2.00 per year - it's hardly even postage, anymore. It was a big step for us to raise the dues to \$3.50, and that was CLEARLY the highest it could go without massive opposition. Now Ski is telling me his photocopy arrangement is touch-and-go on an issue by issue basis. The treasury has NOTHING in it. This could be a problem, if we want it to.

Some members have mentioned to me that they would come to meetings if there were programs instead of just sitting around talking all the time. Some are trying to develop interest in another Mexico-type DXpedition, or the killer Field Days of the past with all the towers and beams, which made the multiply-times-five ten watt category take on a new meaning.

The single biggest issue, though, is club competition. Our Club stands so sharply divided on this one that some members are really losing sleep over it. I agree that the goals of the Club have not been clear to many newer members, but I will not for a moment believe that those goals do not exist. The problem has been one of communication. The members who enjoy the lunch meetings the way they are are the ones who understand the function of the Club. The ones who are dissatisfied are the ones who nobody bothered to tell about the way our Club is. It is not their fault, it is our fault for not being as clear as we could have been.

I hope it is clear to everyone what my dilemma is now. I am faced with a large base of members, many of whom have very different feelings about what our Club should do. It is probably obvious that I feel a great loyalty to the function of the Club as N6TR laid it down when he rebuilt it from nothing in 1980. I also am the leader whom you unanimously elected in January, so I could probably assume that you chose me because you like the way I think. I will admit, however, that there was no other name on the ballot.



This does not make my job very easy at all. Anything I say or do will upset some of the members, but at the same time, I have my opinions about where I want our Club to go. I guess nobody said it was going to be easy.

I have a plan of attack, however, which I would like to implement, and which will give each and every member an opportunity to influence the direction of our Club. I composed a questionnaire for distribution at the last meeting, and personally made sure I received a response from every member who attended. This is not the same questionnaire that was included on the ballot. That one only asked if you were interested in something or not, and gave me no indication of how much. Mine asks you to rank a list of present and possible future Club activities in order of importance to you. I also ask members to rank in order of importance the different kinds of contests. I then ask for YES / NO / NO OPINION answers to three questions which have specifically come up in the last year. This will give me a better indication of which activities are higher priorities than others, and by how much, and whether the membership approves of some key changes or not. I ask that each member who has not already filled one out will take it upon themselves to do so.

In exchange for your effort spent telling me what you want your Club to be like, I will attempt to lead our Club in that direction. You know my ideas now. If you don't agree with them, I won't know that unless you take the time to tell me. The questionnaire is the pull-out center sheet of this issue of the bulletin. Complete it and mail it first class.

Just to spur some of you guys on, here are the results I have received so far:

## N.O.S.C. Scientist Predicts Sunspot Activity

Dr. Adolph K. Paul has written a scholarly paper, "Analysis and Prediction of Sunspot Numbers", that appears in the December 1985 issue of *Geophysical Research Letters*. The paper presents both data and a methodology that may affect the scheduling of future shortwave transmissions and manned space activities.

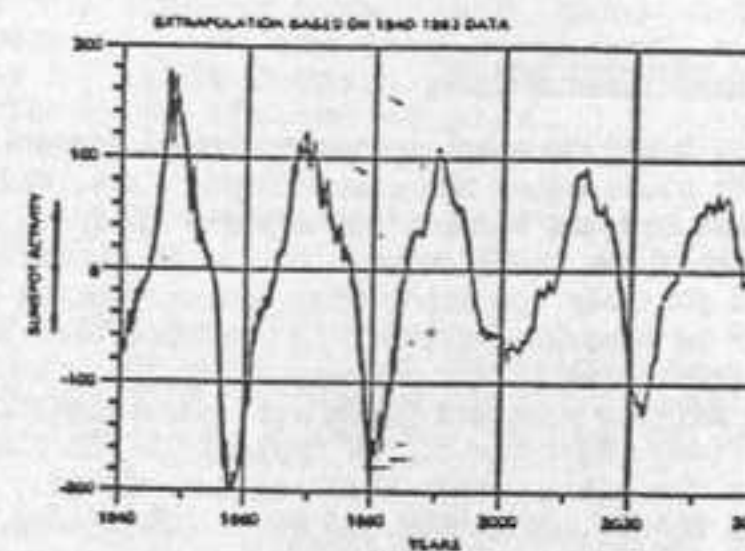
In his paper, Dr. Paul predicts the number of sunspots that will appear annually through the year 2040 (see figure). He does so after employing an iterative procedure that involves, as a first step, a spectrum analysis of the monthly means number of sunspots observed since 1840. Secondly, he extends the data set by using those results for a first order of prediction. After comparing his prediction of sunspot activity with the number of sunspots observed, Dr. Paul revises his formulation to lessen discrepancies between prediction and observation. He repeats the process numerous times, getting, in each instance, a better fit between theory and fact over longer periods of time. He does this until his model satisfactorily accounts for the entire pattern of past sunspot activity. At this point, Dr. Paul uses his model as a predictive tool for the years 1986 through 2040. He realizes, of course, that future observations will necessitate adjustments in his model, but this activity is consonant with the nature of his enterprise, an iterative one.

Dr. Paul's mathematical treatment employs anharmonic frequency analysis, a transform and deals with data that do not consist solely of discrete multiples of a basic unit frequency.

By constructing a methodology that fits past data and promises to make predictions highly accurate, Dr. Paul has provided planners with an effective aid. Knowledge of future solar activity can facilitate effective long-term scheduling of projects requiring either extensive use of shortwave transmission or manned space activity. Intense ultraviolet and X-ray radiation associated with high sunspot activity affects shortwave transmission and may harm people building platforms in space.

Dr. Paul works in the Ocean and Atmospheric Sciences Division of the Marine Sciences and Technology Department. His current research focuses upon ionospheric variability and high frequency propagation.

Dr. Paul's model (the graph composed of dashed lines) closely approximates sunspot occurrences (the solid curve) for the years 1940 through 1983. Greatest sunspot activity occurs at highest positive and lowest negative readings on the curve. Positive values indicate one orientation of the sun's magnetic field whereas negative values indicate the other orientation.

MINUTES OF THE MEETING - MAY 17, 1986

The May meeting was hosted by the Caltech Radio Club in and around the club station on campus, W6UE. An open house began at noon, and several Contest Club members came early to see the station. Just before the meeting started at 2:00pm, we took a tour of the antenna system which covers parts of four different buildings on campus - the largest single antenna being the 3.5 MHz extended double zepp - a 345 foot dipole 100 feet in the air, fed with open wire line (I can write this way if I want - I put that antenna up! -OTU). It points at the East Coast - that's Africa for you DXers.

On hand for the show were members Dick, N6AA; Chris, KG6AR; Irv, W6GC; Leon, W6HAL; Marty, N6VI; Morgan, N6JVV; Paul, N6LL; Mark, WA6OTU; Cleyon, AD6P; and David, AA6RX. Visitors included Bill, W6BA; Paul, KI6CQ; Joe, WL7E; and Dennis, K2SX. Joe ultimately decided to join the club. Welcome, OB, and thanks.

The members present unanimously voted that the minutes should reflect a huge, heart-felt THANK YOU to Ski, N6ADI, for doing such a good job producing the club bulletin SCCCORE every two months.

Marty, N6VI, gave us a well deserved tongue-lashing for not replying to the questionnaire he wrote and distributed at Visalia, in hope of receiving input from the contest operators regarding crucial Contest Advisory Committee topics. His photocopy bill alone has cost him plenty, and he's only gotten 7 (count 'em, seven) of the hundred or so he passed out, back. He cannot stress enough how hard it is to represent people who don't tell him what they think.

Brief discussion of upcoming contest activity for the Club reiterated the fact that Jim, N6TJ, will be coordinating the SCCC CW Sprint Teams for the September running of the Sprint, and that Jim and Marty will both coordinate a Club effort in the All Asian CW contest.

Those present then began grilling our out-of-state guests with different questions. Dennis, K2SX, told us all about 4U1UN. He had some interesting things to say about their non-existent power-level restrictions, and that they only have dipoles as victims of the building codes at the UN. DJ6LV and HB9RS are the hams there to talk to about operating from 4U1UN. Dennis also told us to look for K2LE in the Phone Sprint, operating from Vermont.

Joe, WL7E, informed us about the state of contesting in Alaska. He operates with the KL7Y group out of Anchorage. (I think I got that right). His co-ops are Mike, NL7G, and a 15 year-old NL7GP. Their station consists of three 120' towers with beams, they have a 160 footer in the works, and their location is on a hilltop, and very quiet. Operating out of Fairbanks is KL7RA, who up until recently had a 125' tower topped with a 3-element Telrex Yagi, but now they've lost their site. Too bad. (My apologies if I got any of this stuff mixed up, Joe).

Joe was the target of information hungry contesters trying to find out what they sound like up there, and when the best time to work Alaska was. To this he could say that the Alaskans have a heck of a time getting through to us because everyone in the US proper always has KL7 off the side of their beams - and he added one short bit of priceless contest philosophy, speaking for the KL7s:

"If it's in a contest, you can't give up." ...we finished at 4:00pm.



Along with the President's Report I received a letter from Mark WAGOTU who is now working for the summer in New Mexico. Mark feels that since he has been with the Club longer than I and knows the history of the Club that he has a better feel for what the Club is about and where the Club wants to go. Mark is tired of me chastising the membership and him for lack of participation in contests and activities. Mark feels that the Club is only to provide a meeting place for contesters and other members to tell stories, eat Pizza, drink beer and share knowledge. Included in this Issue of SCCCORE is a mail-in questionnaire for the membership that was composed by Mark to give him a more definitive view of what you as the members want to do and what your view of the Club is, so please take the time to fill this out and send it in to him. It is pre-addressed and is all you have to do is put postage on it and drop it in your mail box. Quite simple actually!

As for my chastisement of the Club I am going to hold a moritorium for the rest of 1986 on any chastising statements against the Club. I do feel that my previous statements were not meant to ridicule the Club but rather were to PUMP UP the membership to a point that some of us would increase our activity and might plan some operations from Southern California conducive to membership participation. I agree with Mark that it is nice to get together every two months for the aforementioned reasons but I also feel that in order for the club to generate new blood that it needs a base of operations that potential contesters and operators can participate in and learn from those of us that have been at it for a while. We have some real expert contesters in our ranks and it seems to me that there are alot of potential and existing contesters around that would like to operate a few contests with these WORLD CLASS OPERATORS to see how the WINNERS are so successful.

The Club is growing and in order to make it grow more I feel that the club should hold at the minimum 1 formal maximum effort to give the members an opportunity to get together and show our wares, bring potential new members out to see the big boys in action and learn some new tricks. Maybe Field Day is the answer or maybe it's CQWW, no matter what contest the CONTEST CLUB should have at the least, one formal effort a year. I feel that if I am a member of a contest club I want to have the opportunity to contest with my fellow members otherwise should it be called a CONTEST Club or the SOUTHERN CALIFORNIA CONTESTS PAST CLUB? The point is that there are local clubs that contest more than the contest club? Don't make sense to me....

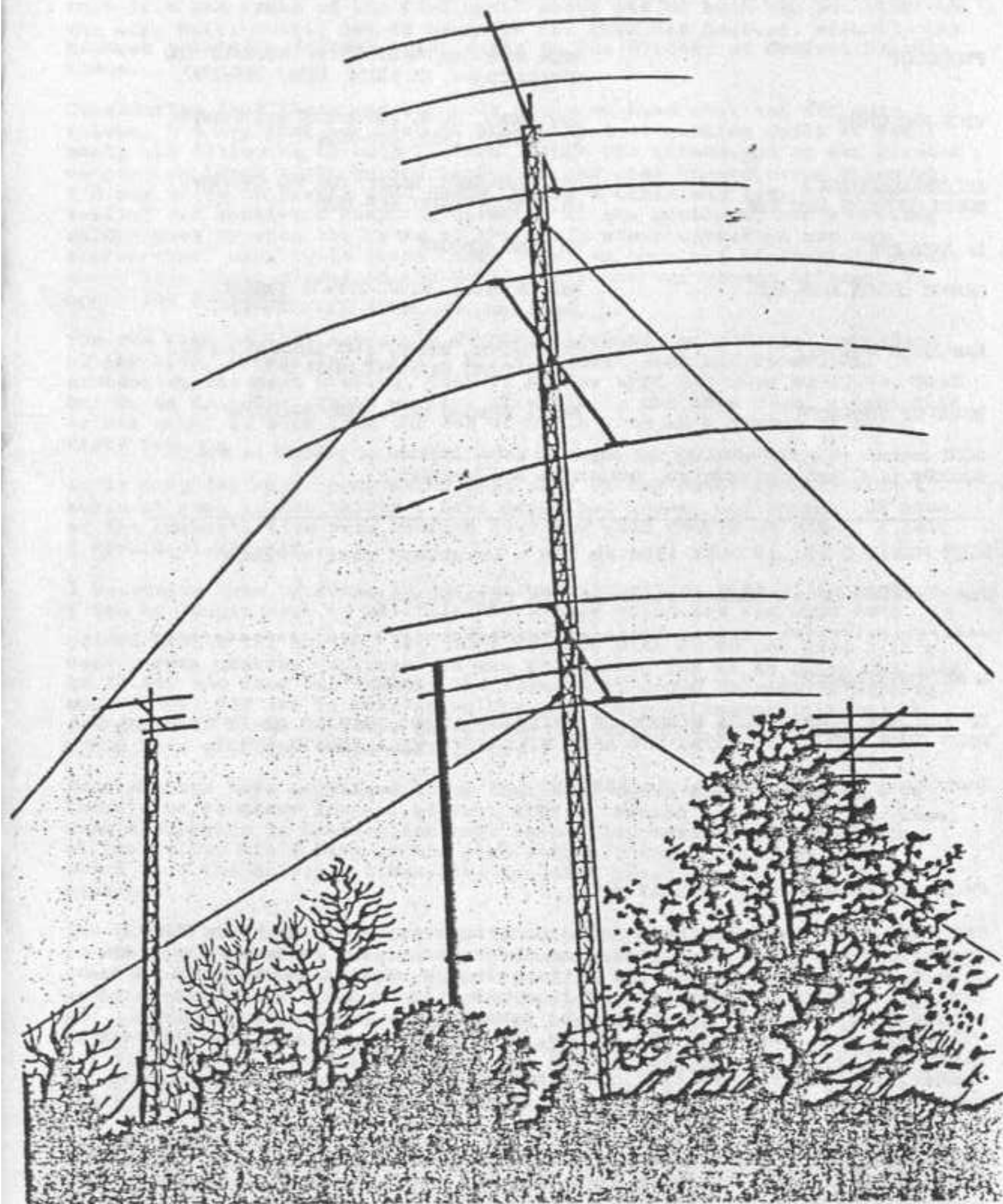
