

AN OPEN LETTER TO THE SOUTHERN CALIFORNIA DX CLUB

The existence of the Southern California Contest Club seems to be viewed as a threat to the DX club. It is the intent of this letter to relieve this tension by making an offical statement of the goal of the SCCC.

The only goal of the contest club is to assemble those who call themselves "contesters" for an informal interchange of contest related subjects (ie booze, sex, and pizza). The idea is to have a select group of people, with a common interest, that is small enough to allow for intimate meetings. That's all folks, no win the world objectives, just basic ego stroking.

It seems that the members of this group are being pressured into making decisions like "who am I going to submit my score for?" This is an emotional issue with most, but I feel it can be resolved.

The Southern California Contest Club will not ambitiously attempt to deprive the DX club from any of its scores. It will not say to anyone, "don't send your score in for the DX club." What a person does with his score should be a personal choice, and a private one at that. I feel strongly that the pressure anyone puts on anybody concerning what to do with their own score is wrong!!

To those that now charge me with splitting up the pie, I invite them to consider this. Indeed, there are a certain number of joint members of both clubs. These people will not be told what to do with their scores. However there are some people in the contest club who have no interest in the DX club. Are we to deny the submission of a club score to these people? Am I to say to them, "I'm sorry, unless you join the SCDXC, you can't submit your DX score for a club?" This clearly violates my stand as stated previously. It works both ways, I can't say "don't send in a score for the DX club," nor can I say "you have to send in a score for the DX club." For this reason the SCCC will submit scores of its own if there are any.

To some, the solution is the merging of the two clubs into one and making the contest club a subsidiary of the DX club. There are several reasons why this is unacceptable and I think this sums it up well: The SCDXC annual fee is 12 dollars, the SCCC fee is 3 dollars. This group doesn't need the big budget of the DX club to sit down together and have a great afternoon. The only reason we have dues at all is to pay for our bulletin.

That's all fine for now, but you may ask of the future. As the contest club grows, its first target will likely be the Sweepstakes It is possible in several years that the club will mount a big effort in this contest, but we aren't even close to that yet. More likely we will just stay a small group without any big plans. Just a friendly group of guys getting together on a afternoon. That is my dream. Now can someone tell me what the hell is wrong with that???
