OAHU Update

Aloha from the 50th state. I must apologize for being so uncommunicative over the last six months, but I hope to redeem myself with periodic editions of OAHU UPDATE. So what's been happening, you ask? Well....

As most of you know, I was transferred last August for the Honolulu office of Coopers & Lybrnad, the CPA firm at which I have worked for the last twenty-plus years. The challenge of getting a whole new client base and learning new industries have kept me from spending more than a modest amount of time with the two things I enjoy most - my family and radio. I'm learning a lot, though, and that is what makes exhaustion better than boredom.

Land prices and terrain being what they are here, there was not much choice in housing but to head up to the North Shore, forty miles and an hour (or two) from Honolulu, if there was to be any chance of HF operation. By a remarkable coincidence of timing, the once-QTH of Randy Sobol, KH6XX, came on the market just as we started looking; we now own that two-acre spread in Pupukea Heights. The place had been vacant for five years and had not been maintained to the high standards Randy had kept. (By the way, Randy and his delightful wife Iris are living in Honolulu with their beautiful three-year-old daughter Jennifer).

Considerable time and resources have been expended in restoring and remodeling the house, but we're close to finished with the big stuff. Along with the house and land, we acquired an excellent radio infrastructure, including:

- six permitted 90' Rohn 45 towers with Wilson WR-1000 rotors
- buried hardline and very beefy rotor cable to all towers
- four big Telrex beams on 15M and two on 10M
- a Telrex 2-element 80M beam and assorted dipoles and loops
- a 700 sq.ft. radio room with six 8-foot operating desks

- five Henry 3K-As, six Drake lines, DVKs, MM2s, etc.
- a flat or negative horizon in all directions (800'MSL)

Unfortunately, deferred maintenance has taken its toll. Several rotators don't work, amps blow up, guy wires are rusting, and much of Randy's documentation has disappeared. The only fully functional band at the moment is fifteen meters, where I entered CQ CW single-band (1880 QSOs, 37 zones and 93 countries with major carpentry work going on right over my head ... remember Phil Gildersleeves' "QRN" cartoon in the old ARRL Operating Manual?). Along with my household goods I shipped two DX Engineering beams, a 20-6 and a 40-3, which are still in their boxes, many coils of EHS guy wire, turnbuckles, grips and thimbles. Once I get and run K6STI's GUY program to figure lengths, we will try to move forward with rehabilitating the towers and installing those new radiators.

Clara, Erik and I were recently treated to a visit and dinner by Dave, W6AQ, and Sam, and I met Darrell. N6DX, in town when he passed through last fall. It's great to see friends from home, and we're looking forward to hosting many of them in the coming years. I've had several calls from friends and even casual acquaintances about guest operating, and I hope to have lots of you over for some multi-op fun. It will take time, advice and help, though, to get running on all cylinders, so please be patient. If someone would like to do some MN modeling while I'm busy tracing wires and making resistance checks on control cables, the process could probably be sped up. If anyone has servicing information - or even an original owner's manual - for the Wilson WR--1000 (my eyes just can't make out the assembly diagram on a faded photocopy), I'd sure appreciate hearing from you.

In a future installment I'll show the physical layout and solicit ideas for antenna configurations, especially on the low bands.
