
address of the web version.

Point: Too Much Power by Jim McCook, W6YA

It goes without saying that we have one of the best hobbies in the world, judging from the comraderie that is so characteristic in ham radio. In times of stress or conflict, nobody comes to the aid of a ham faster than another ham. During my 44 years in this hobby, I have continued to be amazed by this. Other hobby groups and professions have great comraderie; I have seen none where it is stronger than in amateur radio.

In spite of this, however, one thing continues to mystify me. Why are there so many contesters and DXers who cheat? It's like the golfer who picks up his ball to improve his lie or the volleyball player who intentionally carries the ball and expects to get away with it. It is the same person who cheats at cards and crowds into lines. These are people with no pride or responsibility. In spite of the great comraderie, sportsmanship and respect are frequently lacking.

I'm referring to intentionally running excessive power. Over 1500 watts. In some contests it is running amplifiers, period. In QRP contests it is running more than 5 watts. Why, why, why? Do these people think cheating is justified to win at games? Do they think their peers actually respect them for winning a contest with illegal power? Do they think they are heroes when they break through pileups running many kW? Do you think these people are OK to cheat in order to win a contest you have participated in? Do you smile when someone jumps into a pileup using 10 kW and later brags about it?

We seem to have become complacent about this. One distributor of a popular amplifier line clearly advertises a linear amplifier with 5 kW output in the ham section of his web site. In his discussions, he talks about the problem being the operator abusing the use of this huge amplifier. Does he really think hams are dumb enough to believe this? Is there anyone out there who really believes the owner of an amplifier that can run 5 kW output (and much more with that amplifier, by the way!) is running legal power? Sorry, that flimsy story about the cool kW and the conservative use of a husky amplifier just doesn't play. Undoubtedly, there may be a couple of exceptions out there somewhere. Not many. It is a macho game for losers. Real contesters don't cheat.

By the way, I always believed that 30-meters was a wonderful addition to the spectrum because it is a band where people run 200 watts or less. Now I constantly hear that there are many people running high power on 30-meters. Apparently, many DXers on this relatively new band are using amplifiers that they use on other HF bands, in complete defiance of the rules and principles of good sportsmanship.

Does anyone care about this?

Is there anyone else out there who thinks it may be time for some changes? Let's put the cards out on the table. Peer pressure could be the answer.

Counterpoint: Big Amplifiers by Dan Magro, W7RF

Since Jim, W6YA, makes reference to a particular Henry Amplifier advertised at my (radiodan.com) web site in the article you've just read, your editor has given me a chance to respond.

Congratulations to you, Jim, on your 44 years as a ham and (presumably) being a straight shooter for all those years. I have been a ham since 1972 and an active DXer and contester as well, and am the rep and distributor for Henry Amplifiers worldwide. Since 1962, Henry has made hundreds of amplifier types for many different services and needs, many of which cross over a few user groups. Most of the amplifiers we make are not for hams, but sold into commercial/industrial service. However, it is impossible for us or any manufacturer to control where a device ends up and certainly no way of controlling its usage! There are always at least two ways to operate anything!

I too agree with you that cheating in any way just defeats whatever the cheater has won or acquired. That is, in a free society, something that must be evaluated for each of us individually. Fortunately, we are free to do so. I shudder to think what a ban on what some would perceive to be "excessive" in almost any category would do to personal choice. Should we look down our noses at those who choose to own what they think is the best just because those items can be used in an illegal way? What about cars? Should we ban the Corvette? Or the Porsche? It's simply not for me to say you can't own them.
