The recent NCJ notes on page 29 that the NCCC is rejoicing (spelled "g-l-o-a-t-i-n-g") over their club victory in the Calif. QSO Party.

What?! There were no challengers. The contest is sponsored and the results tabulated by them. Does this not make them ineligible to compete in such a "club category" if one even existed? Check the rules - it says nothing about club participation. Granted, the summary sheet has a place to enter your club's name, but where do the rules say anything about it? It is standard procedure, too, that the sponsor is not eligible.

The SCCC amassed 38,133,627 points in the 1984 CQWW. This represents a fantastic effort considering the markedly worse conditions this year. The score is a nearly 3½ million point increase over last year. Based on our average membership of 45, this represents an 847.4K points per person average. If the NCCC had a membership of only 150 (and believe thay have MANY more) their 1984 score works out to 751.3K points per person. TAKE THAT CHICKENS!

If they turn this one down we'll know for sure they're just a has-been club! For our part, this means every SCCC member should start making plans for next fall NOW!

CONTEST ADVISORY COMMITTEE REPORT

The CAC has a new chairman, Randy Thompson K5ZD. It looks as though CAC activity will pick up a bit, with periodic balloting by Committee members to establish consensus on various topics. As in the past, I will occasionally ask for your input, and I will need it on a timely basis so that the whole Committee has the benefit of knowing our positions.

We get many comments re. Field Day rules from around the country, and I have taken on the task of summarizing them for the Committee. This year's rules are at the printer's; the only change you'll see is an additional bonus for the use of packet radio (similar to the satellite bonus). For future consideration are such ideas/complaints as deleting all advance set-up, prohibiting any use of commercial mains - lights, rotors, etc., penalizing use of beams, deleting the power multiplier, longer exchanges, adding WAE-style QTC credits, deleting message relay credit, and prohibiting use of bateries in connection with "natural power" bonus. The basic struggle is between those who think the most effective stations (tower trailers, beams, power, etc.) should not be penalized because they are really best prepared for emergencies and can "get through", and those who want to make it easy for the greatest number of stations to get on and "compete". I strongly favor the former position, but I can sympathize with the other side ... after all, what fun would FD be if only a few hundred stations were on the air?

Should the dx "window" on 160 meters be enforced or ignored in the ARRL 160 Meter Contest? I have circularized a few of the SoCal big guns on 160 but would like to here from anyone else with a thought on this. As for the Contest Code of Ethics, the opinion I got from most of you was that it's "motherhood", nice but unenforceable. I have expressed this to the rest of the Committee. The issue of whether to allow single-ops to use repeaters is being debated. Your opinions, like mine, are that a well structured spotting repeater can help - rather than distract - even the best single-op's. I have expressed our opposition to allowing such use to the Committee.

I'm working on proposed VHF/UHF rules based on distance scoring, but have input from only one person so far (N6NB). How about the rest of you? Finally, Everyone complains about the affiliated-club-competition rules. Some of you suggested -- and I agree -- that the three tiers should be scrapped, with total club membership shown parenthetically next to the club name and score so that clubs can draw their own comparisons. This would discourage "cherry-picking" and encourage broad participation.

Given the "coincidental" choice by SCCC of a single 7A station (how many Southern Cal VHF stations do you have lined up, anyway?), 90% of the NCCC would be forced to sit on the sidelines.

The numerous victories of the NCCC (6 Sweepstakes club victories, 1981 and 1983 COWW club victories, to name a few) were the result of an all-out club effort -- we all participated and we all K'd some B. In other words, James of Africa, we won because each member of our club got excited about a particular contest and made the personal sacrifices to both get on the air and bust his/her derrière to make a maximum score. We used the call NS6X and totaled out at 554 mults/5,400+ pts/2054 QSO's for a score of 2.95mil, it looks like we ran neck and neck with N7TT who beat us out last year by a nose. I guess we'll know for sure in 9 months. NE6I came over to boost our number and he was a welcome addition to the North Counties Contest Group. That's NCCG not NCCC! Out of 22 operaters contacted we had a 50% turn out for 11 died in the wool contesters.

We are looking for help with CW effort on Memorial Day Weekend! Its always hard to find people for the CW portion cause alot of the Dick BASH grads can't copy CW or go camping with the crowds on that weekend. So its always a challenge to come up with a crew. I think everyone ought to practice for the CQWW effort so we can back our challenge to the formidable group up NORTH. I talked to Carl AI6V a couple times in the past two months and the NCCC has a good reason to turn us down for Field Day. As you know we all learn from our own experiences, well, so have they! The following was gathered from Carl. Thanks Carl!::

A number of years back the NCCC decided to flex their muscles in the ARRL annual Field Day Event. They went to great lengths to put together a SUPER STATION comprised of the following incomplete list of equipment: 3-monoband beams on every band from 10-80 meters, towers for all the antennaes, campers, tents, 3-4 tranceivers for each band, a 15KW generator (brand new borrowed from emerg. services), other generators and lots more equipment. This was all amassed and assembled on a hilltop somewhere in NCCC country which by the way gets rather warm in the summer. We've all had encounters with Murphy, Well, he not only reared his head but his whole body on this effort! The solar activity took an upward turn (good for UHF, VHF but bad for the low bands), two to three of the NCCC hot ops got a case of sun stroke, the 15 KW generator (borrowed) sucked a valve and gave up the ghost, between the sun and the temperatures on this hilltop most of the NCCC'ers either suffered from heat prostration or a mild case of sun-stroke (not to mention the 2-3 that needed immediate medical attention) and the whole effort was DOOMED.


