#### PRESIDENT'S REPORT

At the last meeting it was decided that the club will push for a respectable score in the CQ WW contests. We have several members who will be abroad for the contests, and if there is some activity from the rest of us, a fairly large score will result. (We need a BIG score—see Tree's letter to the NCCC elsewhere in this issue—ed.)

The best way to run up a large score (and to save energy for the Sweepstakes) is to go multi-operator. This way, you can take advantage of spotting receivers or nets to help your multiplier total and have enough sleep to function during JA pileups. To help each other obtain better scores, we will have our own SCCC spotting net. I think the best place for the net is 40 meters. This allows good coverage during the day when the spotting function is most useful. Let me know if you have any ideas on this.

Sunday, October 10 is a KB6I station open house. We will meet about 1:00 pm. Preparations for the CQWW will be made at this meeting.

#### SCCC NOTES

The July meeting was attended by Mike WA6JAH, Jim N6RJ, Dave AA6RX, Hank W6SX, Jim N6TJ, Tree N6TR, new member Kurt NI6W, and myself.

As Tree mentioned, we have decided to make a meaningful effort in the upcoming CQWW contests. A challenge has been issued to the NCCC and full plans are beginning to blossom. Thus far the following dxpeditions are planned by club members: N6AA at 9Y4VT (cw and possible SSB), N6NI at 9K2DX (cw), N6RJ at ZF2FL (ssb), N6TJ at 8P6J (cw), N6ZV at FM7??, and possibly AA6RX at P41 (cw).

In addition, we are planning a multi-single or multi-multi at KB6I for both SSB and CW. Also we will want as many other stations as active as possible (even a few hours if that is all you can do).

N6ZV has volunteered the use of his station while he is in Martinique for the contests. He says it would be best for a single or multi-single. The antenna farm boasts 2 el on 40, 4 el on 20, 5 el on 15, 5 el on 10, and a dipole on 80. It would be a BYOR (bring your own rig) affair. Please contact him direct if you are interested.

Many favorable comments have been received regarding moving our meeting dates to the same day as the TRW swapmeet. Tree has agreed that this would be a desirable change with some flexibility at times to avoid major contests. There will probably be a permanent move to those dates in the near future. The September meeting will be the first trial at having it after the swapmeet. The swapmeet starts at 7:00 am, meeting at 11:00 am.

The February 1982 Sprint produced 15 new state and province records including a new California record of 13,243 points by N6TR! Also, the west coast team, WASP #1, took top team honors (only the second time ever the Independent Contesters failed to win!). It is interesting to note that every entrant from the 6th and 7th districts was either on WASP #1 or WASP #2 teams or no team at all.

The 1981 CQWW SSB results are out and a standing ovation must be given to Dick N6AA who piloted 9Y4VT to an all-time single op record of over 11 million points! Jim N6RJ compiled another fantastic score as a single band entry from ZF2FL but finished second to VP2KAA. P41C amassed the largest score ever in a contest (42 M) as a multi-multi (our own AE6E was a part of that). Quite a few other SCCCers appear in the results. Congrats to all for a fine showing and let's do at least as good this year!

I naturally have to mention the recently released list of high claimed scores for the 1982 CQ WPX SSB contest, because yours truly placed 8th in USA all-band in my first try at this contest. I feel pretty good about that!

Noop has come up with a new form of contesting which he calls SCOPE (Sane Contest OPerating Experience). The idea is to operate no more than 10 of the first 24 hours of any contest with breaks of minimum 30 minutes as an all band single op enty. Then send a copy of your DUPED log and summary sheet to Bill Zachary Noop, 7027 Buckingham Blvd, Berkeley, CA 94705. He will send you a list of high claimed SCOPE scores. He emphasizes CW only contests. Now you can operate all of the big contests and keep tuned up for your favorites while competing with others.

Hank W6SX is planning to operate the California QSO Party from his house in Mammoth which will put rare Mono County on with the potential for a big score. Hank is considering the possibility of a multi-single effort with one other operator. If you're interested (bring your wife, too) contact Hank at 805-258-4736 evenings.

Hank mentioned he received the NCCC bulletin recently and it stated they had received Tree's letter challenging them in the CQWW. Well, their heads are in the clouds after their recently announced victory in the 1981 contest and

the bulletin didn't sound as if the challenge was taken seriously. No problem---just as long as they accept. WE will be ready!


